- Managing existing and new data collection systems to ensure that they are effective, efficient and secure.
- Overseeing quality assurance arrangements to ensure data collected and reported is timely, accurate and compliant with any relevant regulatory frameworks, including GDPR.

- Informing the organisation's digital product roadmap, to ensure that the digital products deliver the requirements of the data strategy.
- Working with the senior leadership team and research team to capture the impact of the Company and express this through innovative and engaging means including data visualization.
- Leading the development of, and reporting arrangements for, the measures that the organisation and funders judge its progress.
